

PEARL CITY BOARD OF EDUCATION  
Regular Meeting  
April 21, 2021

President Bremmer called the Regular Meeting to order @ 6:30PM.

After Roll Call the Board approved the April 21, 2021 agenda.

The Board recognized guests and public comments were allowed. There were no public comments.

The Board approved the Consent Agenda consisting of the minutes from the March 17, 2021 regular board meeting and closed meeting minutes and bills and payroll through April 16th, 2021 for \$446,728.38.

Communications:

1. Dr. Schiffman shared that the district would be receiving two additional ESSER federal grants. Esser II is for \$262,334 and ESSER III is for \$588,881. The grants will be used to purchase technology, curriculum and to help with facility updates to help with air ventilation.
2. Dr. Schiffman discussed the need for a Special Education van. The current van has over 200 thousand miles.

9. The School Board approved the hiring of Jeff DeLay as Asst. Musical Director for the 2021 Musical.
10. The School Board approved a two-year agreement for Speech-Language Therapy Services and Special Services Coordination with Jen Petta.
